



Otherwise, the products might lose the required moisture level and its mechanical properties. In this case, you can re-condition the products according to the internal standard WE-Standard 1581 to ensure the required moisture level in the plastic.

For further information about this internal standard please refer to the document 'WE-Standard 1581' which can be downloaded from the respective product page on our website.

To ensure the operating mode of the product, the ambient temperature at processing (when the part will be mounted on the cable) has to be in the range of 15 to 35 °C. Before mounting, the part should be stored for one hour in this condition. Direct mechanical impact to the product and the forcible closing of this shall be prevented as the ferrite material of the ferrite body or the plastic housing could flake or in the worst case it could break.
